Hi Jelili, TN communicated abnormals to our follow up group. We don't test for glycine so TN had to do the follow up testing for that specimen. We don't have plans to add that right now. We are definitely including this in our COOP plan (we didn't have it before).

Charges per specimen are an important factor. TN ended up charging us our rate for the specimens and not their rate which is more (\$127 vs. \$165).
